SPACE IS LIMITED TO ONLY FIRST 50 APPLICANTS. PLEASE REGISTER AND RESERVE YOUR SPOT.

RULES AND REGULATIONS

- 1. There will be two age groups:
 - a. Ages 10 and under
 - b. Ages 11 to 15

Each competition team will consist of ONLY one person.

- 2. The child must do the preparation, cooking and presentation. Parents my help with fires and slicing or anything considered dangerous. If a child is unable to do all of the above on their own they are too young to cook.
- 3. Accommodations will be made for children with disabilities. Parents must contact All American Smokers Management within 2 weeks of competition to review child's needs.
- 4. All children will cook in a designated area on grills provided by All American Smokers. Families with more than one child participating can cook on the same grill if they choose.
- 5. A parent/guardian must be present with the child during the entire cooking process.
- 6. Entries will be submitted in numbered containers provided by All American Smokers.
- 7. Garnish (lettuce, parsley) is permitted.
- 8. Slicing meat for presentation is not required. Judges will be equipped to slice the presentation at the judging table.
- 9. Judging will be based on APPEARANCE, TENDERNESS, TEXTURE, TASTE.
- 10. Judging ranges are from (9) being the highest to one (1) being the lowest.

SAUCE COMPETITION

ENTRY FEE: \$10.00 PER ENTRY

SAUCE: Must prepare enough for 8 judges. You will be provided with a 16 OZ

container.

GARNISH: No garnish will be allowed.

CONTAINER: You are required to present your entry in the standard Styrofoam 16 OZ

pre-numbered container.

TURN IN: Entries must be submitted in the provided container.

PRIZES: Prizes will be given to the top scoring contestants in the 10 and under

division and the top scoring contestant in the 11 to 15 division.



SPECIAL INSTRUCTIONS

DEFINITION FOR FOOD CATEGORIES

CHICKEN: The breast of a chicken.

STEAK: A steak of any size.

Upon arrival, check in at Registration Area for your space assignment. A special area will be designated for the kids cooking area.

KIDS MEETING: 8:15AM, Saturday, October 3, 2020, in front of staging area. (It is

mandatory that you attend the meeting and pick up food

containers.

SUPPLIES: A grill will be provided to each KID CONTESTANT. Contestants

must supply all of his/her cooking ingredients, cooking utensils, and must cook in grill provided. Teams have also found the following supplies helpful: tables, chairs, paper towels, hand sanitizers, disinfecting wipes, cutting boards and plates for prep.
